

## **Annex A to the ABN AMRO Group Binding Corporate Rules**

1. The binding effect of the ABN AMRO Group Binding Corporate Rules (“**BCRs**”) extends to the ABN AMRO Group members that are listed below (“**BCR members**”).
2. Unless stated otherwise in this Appendix, capitalized terms have the meaning as set out under article 2 (‘Definitions’) of the BCRs.
3. ABN AMRO will inform the BCR members of any relevant updates to the BCRs.
4. All processing of Personal Data performed by the BCR members is in scope of the BCRs, including but not limited to processing Personal Data of a Data Subject acting as Employee, processing Personal Data in the context of a business relationship between a BCR member and its Clients or Clients of ABN AMRO Group or an ABN AMRO Group Company; processing Personal Data in the context of the relationship with ABN AMRO Group or ABN AMRO Group Companies. Furthermore, the BCR members may process Personal Data to abide by legal obligations, for security purposes and use personal data to conduct its regular business activities with partners or counterparts such as (potential) suppliers or vendors.
