## 2 Ongoing charges

You also pay charges incurred by an investment fund. These include the management fees, administration fees and marketing and distribution expenses. These charges are included in the price of the investment fund and are set by the investment fund. The management fees and administration fees are set out in the Key Investor Information Document (KIID) published by the investment fund. ## 3 Transaction charges in funds

Many fund managers actively manage their fund and trade accordingly. The fees for the buy and sell transactions within the fund are included in the price of the investment fund. These are the charges as stated by our external data provider, Six Telekurs. The charges differ per fund provider and investment fund.

## 4 Other charges

'Other charges' comprise the swing price and the bid/ask spread.

Swing price: Swing pricing is a technique for eliminating the negative impact of investors entering and exiting the fund for existing or incumbent shareholders in a fund. The buyer therefore pays an extra levy on top of the price of the fund to cover the costs caused by his transaction.

Bid/ask price: the ask price is the amount for which you can buy an investment product. The bid price is the amount for which you can sell an investment product at that time. The difference (the spread) comprises the charges that you pay. We use the following bid/ask spreads in these Indicative Profiles: Domestic and Foreign Equities and Closed End Investment Funds: 0.0439%. Open End Investment Funds and ETF Trackers: 0.015%. Turbos: 1.00%. Options: 2.00%.
