

Terms and Conditions for First Year 50% Discount on Annual Fee

Issued by:

1. This promotion is issued by International Card Services BV, Wisselwerking 58, 1112 XP, Diemen (hereinafter: ICS).

How this promotion works

2. The promotion period runs from 1 April 2026 until 31 December 2026.
3. You can participate in the promotion with a welcome gift of 50% discount on the card fee during the first year if you:
 - o apply for an ABN AMRO Business Card or ABN AMRO Corporate Card within the aforementioned promotion period;
 - o have your application approved by ICS.

Promotion Terms and Conditions

4. You may participate in this promotion only once during the entire promotion period by submitting one application. You can apply for multiple Cards per company in one application.
