Why are we asking you for this disclosure?

Like you, we want to know who we do business with. In accordance with the Dutch Financial Supervision Act (Wft) and the Anti-Money Laundering and Anti-Terrorist Financing Act (WwFT), we can only do business with organisations of which we have all the correct data. Therefore, we are obliged to know the legal and authorised representatives as well as the Ultimate Beneficial Owner (UBO) and update this information in case of any changes. Who is considered an Ultimate Beneficial Owner?

An Ultimate Beneficial Owner is a natural person who is the ultimate owner of or has the ultimate control of the organisation. This means that this person has:

- more than 25% (in)direct ownership in your organisation. For instance through possession of shares/certificates (e.g. with a private or limited company) or can make use of or has a claim to the yield/capital of the organisation (e.g. Partnership).
- more than 25% (in)direct control of your organisation. For instance through voting rights, authority to appoint or to dismiss the board, holds a pledge or someone who can amend the partnership agreement.
- an (un)official position in which Actual control over the strategy / daily operations is determined. For example a previous owner of a company who is still frequently involved.

Attention! Abovementioned may also apply to yourself. If none of the abovementioned situations apply to your organisation. Fill in the complete current board of directors as in accordance with the articles of association or as registered in the Company Register.

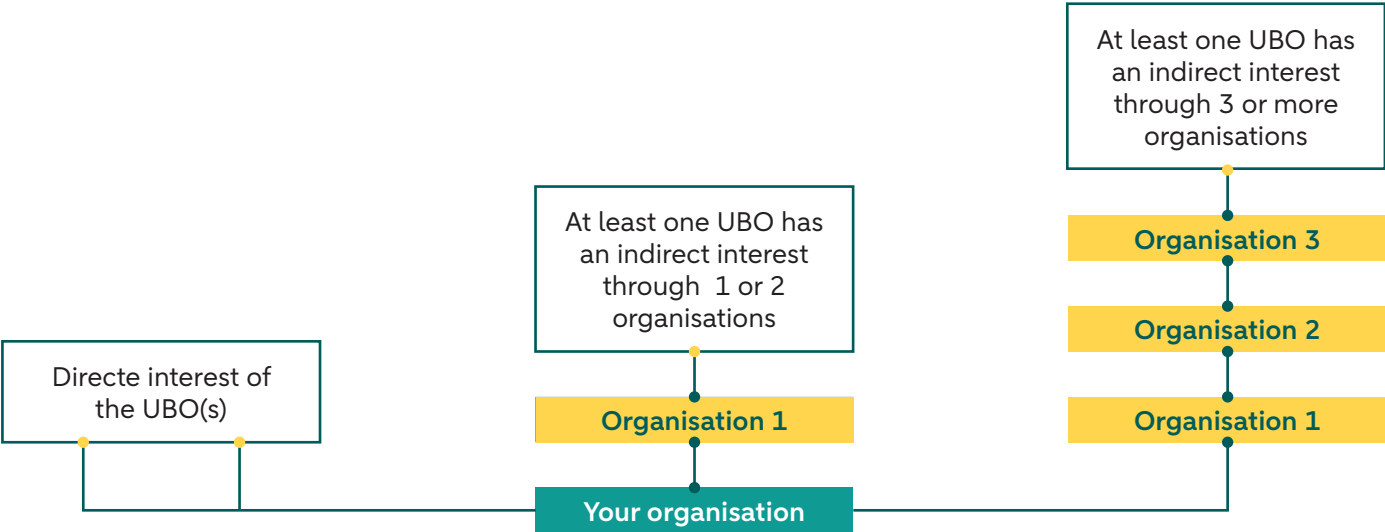
